2.0 Overall average (on a 4.0 scale) required.
C or better required on articulated courses
Program must be commenced within 2 years of graduation.
Students must complete Keyboarding Applications prior to graduation. This is normally completed in the 7 th grade.
Students may only receive credit for four articulated courses when pursuing an associate degree.
Students may be required to demonstrate knowledge/skills on articulated courses.
Articulated credits may not transfer to other institutions.
